



### Special and/or Sensitive Personal Data We Process



## How Long We Retain Personal Data

**daisy james** does not retain your personal data longer than necessary to achieve the purposes for which your data is collected. We have a retention period of 2 years for the following personal data: personal information, address, contact details, bank account, and any other data you provide to us. Data is deleted after 2 years of inactivity (last activity, delivery, and/or payment). We have a retention period of 7 years for administrative data (invoices) for tax purposes.

## Sharing Personal Data with Third Parties

**daisy james** never sells your data to third parties and only provides it if necessary for the execution of our agreement with you or to comply with a legal obligation. We enter into a data processing agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. **daisy james** remains responsible for these processing activities.


## Cookies and Similar Techniques We Use

**daisy james** uses only functional cookies and analytical cookies that do not infringe on your privacy. We have taken the following measures:

1. Signed a data processing agreement with Google.
2. Anonymized IP addresses in Google Analytics.
3. Turned off data sharing with Google.
4. Turned off data sharing with Google for advertising purposes.
5. Set a data retention period for Google Analytics at 26 months.

A cookie is a small text file that is stored on your computer, tablet, or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your convenience. They ensure that the website works properly. We can also use them to optimize our website. You can opt out of cookies by configuring your internet browser not to store cookies. Additionally, you can delete all information previously stored through your browser's settings.

## Accessing, Modifying, or Deleting Data
